- **PCAV EPD's Initiative**

PCAV is working on an initiative to position itself to address potential regulatory requirements that could adversely affect the concrete pipe and precast concrete product industry through EPD's and Buy Clean Competitiveness initiatives that have gained interest and strength in other states. We are working on an educational piece to share with legislators, VDOT officials, key decision makers and additional industry members should the Virginia General Assembly decide to move forward with EPD legislation. While there has been no indication – at this time – that the GA or VDOT will make a move to require EPD's there are producers in the Commonwealth that have already received requests for EPD information.

- **VTCA District Dialogues**

- *PCAV was pleased to sponsor Northern Virginia, Culpeper & Fredericksburg, and Hampton Roads District Dialogues. Hosted by VTCA, these fall dialogues took place around the Commonwealth September 23, October 29, and November 6. In addition to our sponsorship, we included these events in our newsletter and on our website, in our listing of industry events around the state and nation.*

- **Virginia Statewide and House of Delegates Election Results 2025**

- *Virginia received national attention early November with one of two races for Governor; the other in New Jersey. Our Congratulations to Governor-elect Abigail Spanberger, who received 57% of the vote., Lt. Gov-elect Ghazala Hashmi, and Attorney General-elect Jay Jones received 55% and 53% respectfully.*
- *In addition to the statewide elections, the composition of the House of Delegates shifted significantly. Seats that are Democrat controlled increased from 51 to 64. The construction of the Senate remains 21-19 Democrat controlled.*
- *According to [Virginia Public Access Project](#), more than 1.4 million people across the Commonwealth took advantage of the opportunity to vote early. This is an estimated 230,000 more early votes cast than in 2021, an estimated 22 percent of the total number of registered voters in Virginia.*
- *PCAV warmly welcomes all newly-elected and re-elected officials. We look forward to working with our [17 newly-elected delegates](#) as well as members of Governor-elect Abigail Spanberger's Administration. Together, with our partners, PCAV will continue our mission to educate officials on the advantages and proper utilization of precast products and systems.*

PCAV is also delighted that the 2026 AASHTO Comp is coming to Richmond August 2-8, 2026, and plans to support this conference.
- **2026 PCAV Winter Meeting**
